
ORDER RESCINDING DEFAULT ORDER

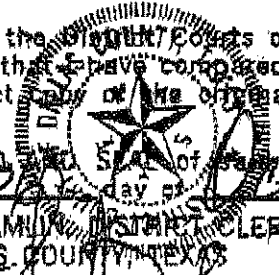

RESPONDENT'S ORIGINAL ANSWER

JAMIE ROSENTHAL, Respondent, files Respondent's Original Answer to Original Petition for Divorce and shows:

1. *General Denial*

Respondent enters a general denial.

2. *Attorney's Fees, Expenses, Costs, and Interest*

It was necessary for Respondent to secure the services of Diane L. Snyder, a licensed attorney, to prepare and prosecute this suit. To effect an equitable division of the estate of the parties and as a part of the division, and for services rendered in connection with conservatorship and support of the child, judgment for attorney's fees, expenses, and costs through trial and appeal should be granted against Petitioner and in favor of Respondent for the use and benefit of Respondent's attorney and be ordered paid directly to Respondent's attorney, who may enforce the judgment in the attorney's own name. Respondent also prays for attorney's fees, expenses, costs, and interest as requested above.


